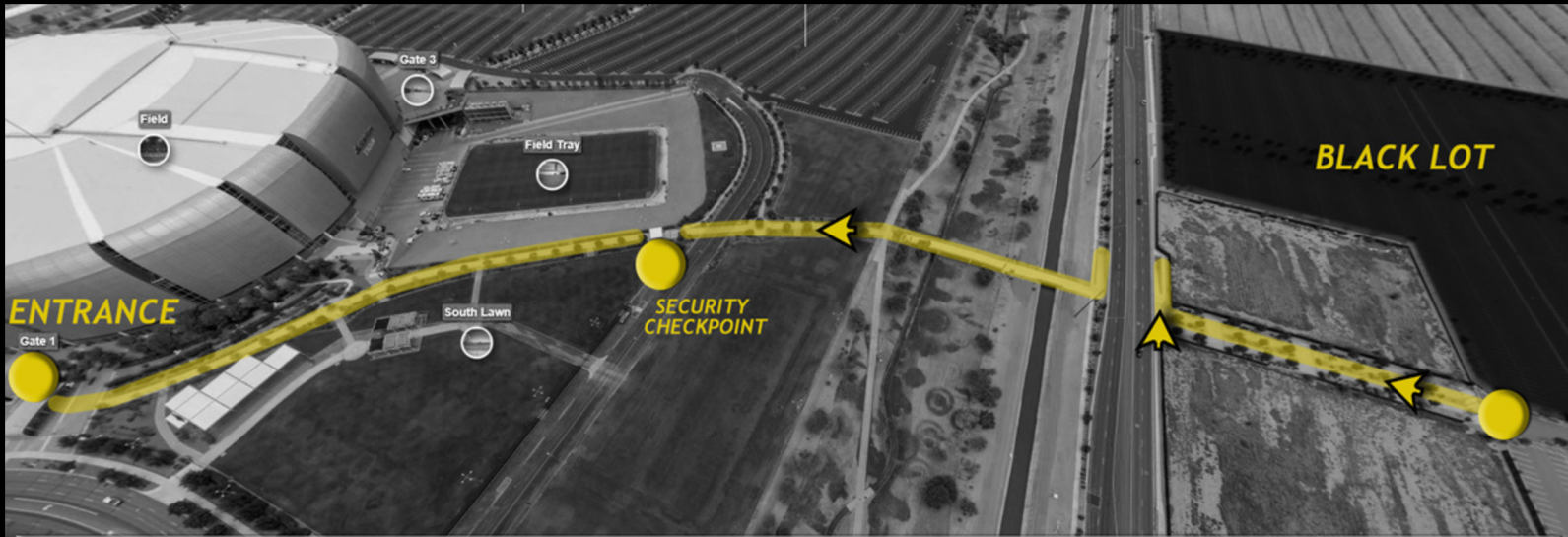

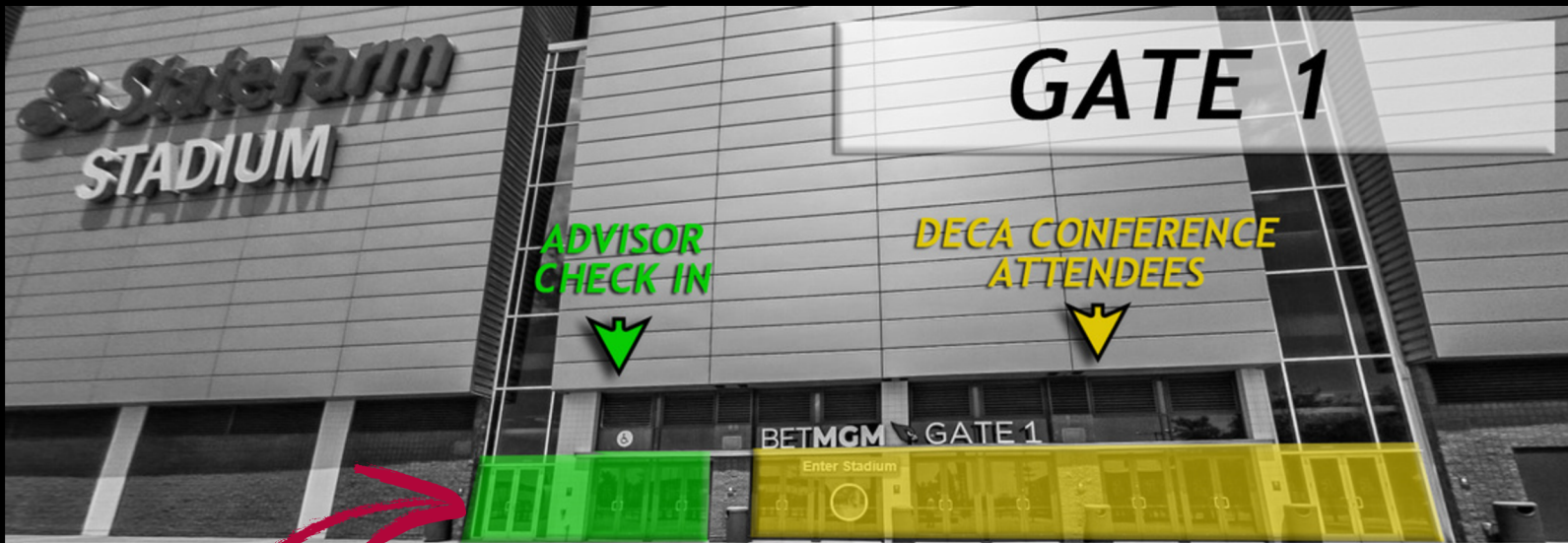

DIRECTIONS FROM LOT

****REMINDER STADIUM HAS A CLEAR BAG POLICY. LEAVE BAGS IN VEHICLES****
ENTER BLACK LOT FROM MONTEBELLO AND 95TH AVE TO PARK. FOLLOW SIGNAGE AND TRAVEL NORTH ALONG THE TREE LINE TO THE BLACK LOT TUNNEL. TRAVEL THROUGH SECURITY CHECKPOINT HEADING NORTH TO GATE 1. AT GATE 1, WRISTBANDS FOR ENTRY WILL BE DISTRIBUTED BY YOUR ADVISORS.



CHECK IN INSTRUCTIONS

****ADVISORS - CHECK IN AT FAR LEFT DOORS (NORTH DOORS) AT GATE 1. CHECK IN TABLES TO COLLECT WRISTBANDS LOCATED INSIDE. DISTRIBUTE WRISTBANDS OUTSIDE GATE 1 ON PLAZA TO ATTENDEES IN YOUR GROUP BEFORE ENTRY VIA THE SOUTHERN DOORS AT GATE 1****

ARIZONA DECA BRANDED CLEAR DRAWSTRING BACKPACKS WILL BE ACCEPTED FOR THIS GAME DAY ONLY. ALL OTHER BAGS HAVE TO FIT WITHIN THE APPROVED DIMENSION BELOW

THE NFL BAG POLICY PERMITS ONLY THE FOLLOWING BAGS IN ALL NFL STADIUMS:

The NFL Public Safety Policy includes the type of bag fans can bring inside State Farm Stadium. This will also speed entry on game day. Here is everything you need to know for a safer, more convenient day at the stadium.

- Bags/Totes, Backpacks, Fanny Packs or Cinch Bags that are clear (see-through) plastic, vinyl or PVC and do not exceed 12"x12"x6"
- One-gallon clear (see-through) plastic freezer bag
- Small clutch bags including wallets not to exceed 4.5" x 6.5" x 2" (approximately the size of a hand), with or without a handle or strap, may be carried into the stadium along with one of the clear bag options.

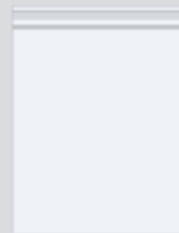
CLEAR TOTE

PLASTIC STORAGE BAG

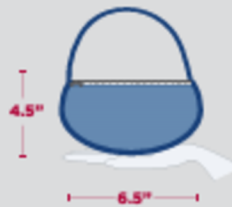
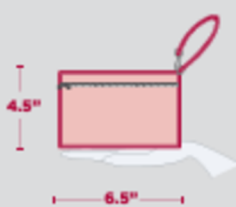
1 GALLON RE-SEALABLE, CLEAR



INCLUDING: CLEAR BACKPACKS/ CLEAR FANNY PACKS/CLEAR CINCH BAGS THAT FIT WITHIN THE PERMISSIBLE DIMENSION

SMALL CLUTCH BAG | INCLUDING WALLETS

APPROXIMATELY THE SIZE OF A HAND WITH OR WITHOUT A HANDLE OR STRAP. NO LARGER THAN 4.5" x 6.5".



NO BUCKLES, GROMMETS/HARDWARE OR DECOR CAN OBSTRUCT OR CONCEAL ANY PART OF THE BAG.

PROHIBITED ITEMS

Fans are reminded that the following items will not be permitted inside State Farm Stadium. Security team members cannot hold any items for fans. There are lockers available outside of the stadium to secure items not allowed inside.

- Aerosol Cans
 - Alcoholic Beverages
 - Animals (except for documented service animals)
 - Bags that do not meet NFL guidelines (must be clear and less than 12" x 12" x 6" in size)
 - Banners or signs larger than 3' x 2' or with a non-sport message
 - Beverages other than one (1) factory-sealed, non-frozen 500mL (16.9 fl. oz.) plain bottle of water (sport drinks and flavored water not permitted)
 - Beverage containers – cans, glass bottles, souvenir cups, and thermoses
 - Cameras with professional lenses (larger than 8 inches) and tripods/ monopods
 - Chewing tobacco
 - E-cigarettes/Vaporizer Pens
 - Clothing deemed obscene or indecent in a public setting
 - Coolers of any kind*
 - Fireworks
 - Food (except for children under the age of two years old)
 - Footballs and beach balls (inflated or deflated)
 - Illegal drugs
 - Laptop computers
 - Laser pointers
 - Marijuana- Usage is illegal within State Farm Stadium and Sportsman's Park per Arizona Revised Statute 36-2851.8a
 - Noise makers of any kind (whistles, horns, bells, etc.)
 - Poles or sticks of any kind, including "Selfie-Sticks" and brooms
 - Seat cushions except those which are one piece and have no zippers, pockets, or concealable areas
 - Skateboards, golf carts, rollerblades or hoverboards
 - Souvenir popcorn buckets
 - Strollers, Wagons & Car Seats
 - Umbrellas larger than 12 inches in length
 - Unmanned aircraft systems (drones, etc.)
 - Video cameras (single purpose)
 - Weapons or explosives of any kind including, but not limited to, firearms and knives
 - Any item deemed inappropriate or hazardous by stadium security
- *Exceptions will be made for all medically necessary items after proper security inspection.
